Petition of the Health Consumer Advocacy Alliance: To establish an independent Patient Safety Commissioner accountable to Parliament.

### **Petition request**

That the House of Representatives establish a fully resourced, independent Patient Safety Commissioner (PSC) accountable to Parliament to take a proactive approach to preventing patient harm, with powers to take or require action.

### **Petition reason**

We believe too many people have been harmed in NZ's health system because of system failures that have not been identified through existing processes. In our view, the HDC, HQSC, ACC and Medical Council lack independence. Existing processes primarily only respond after harm has already occurred, rather than being able to proactively assess and prevent systemic harm. We see a better model than the NZ status quo in the English and imminent Scottish independent Patient Safety Commissioners.



### Where is the independent voice in our health system?

Constant news articles with terrible experiences of those receiving care in our health system says it all.

Those who have been harmed should not have to fight to prevent others from suffering the same harm, over and over again.

Health professionals are struggling, many are frustrated, overworked and overwhelmed and they need more support.

An independent Patient Safety Commissioner would focus on our health system as a whole, looking for the gaps, proactively working with our health agencies to encourage transparency, and ensure accountability for fixing the systemic issues that enable more harm to continue.



- 1. Health professionals do you feel safe in your work place, is your expertise validated, if you raise concerns is appropriate action taken?
- 2. Health advocates do you feel your concerns are taken seriously? Is anything really changing and do you feel heard?

# Who is challenging the status quo?

- 1. Do you know what powers our existing health entities have, and what they can and cannot do?
- 2. Do you feel there is enough transparency regarding what is happening behind the scenes?
- 3. With the state that our health system is in, do you feel that an independent voice and scrutiny of our health system as a whole is needed?
- 4. Do you want someone to take a proactive role in sorting out the mess our health system is in, instead of the reactive response we have now?



### Why this role will make a difference; a PSC is not more of the same!

The PSC would be a **proactive** force, ensuring that there is less siloing of information within existing agencies, and that there is a timely, cohesive and concerted response to evidence and patterns of harm.

A PSC would look through a different lens to ensure all health entities are truly investing in patient safety, as opposed to it looking good on paper or being tokenistic.

A PSC will both support and work collaboratively with our health entities and govt to make meaningful change.

A PSC will be a visible voice for consumers, for vulnerable New Zealanders that are not being heard in our health system now.

AN INDEPENDENT PATIENT SAFETY COMMISSIONER would work in harmony with all of our health entities providing support and guidance, acting as the glue that brings them all together



### What do we have now?

- > HDC primarily focuses on harm after the event, as does ACC and the Medical council.
- ACC safety/prevention initiatives do not include treatment injury, and their harm data capture systems do not align with other health entities databases, so it is not accurate. Their response to monitoring harm is reactive, after harm has already been done.
- HQSC focuses on patient safety, improving consumer engagement but is not independent and has no legislative enforcement powers.
- National Quality Forum meetings remain behind closed doors with little transparency about what discussions take place and what actions are taken when concerns/ red flags are raised.
- The Ministry of Health/Government have limited powers over the private sector and unable to enforce urgent change when needed.
- CARM and Medsafe have limited legislative powers and ability to identify harmful medicines/devices and react with a timely response, even when red flags have been raised.
- Te Whatu Ora have no legislative mandate, are not independent and do not have an independent voice.

Because our current harm reporting processes are woefully inadequate, it makes it difficult for our health entities to successfully identify, monitor or address harm. This means it keeps on happening!
